- 2. On-Site Registration available until the start of Level 9 of each starting day of this event.
- 3. Players may Re-Enter until the start of Level 9.
- Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
- 5. Levels will last 15 minutes each.
- 6. Redraw at 27, 18 and 10 players or at Tournament Director discretion.
- 7. Tournament Director decisions are final and without recourse.
- 8. This is a one-day tournament and plays until completion.
- Management reserves the right to alter, change, or cancel this tournament. Management will not be held responsible in the event of typographical errors or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters.
- 10. Any unauthorized chips introduced into tournament play will be immediately removed upon detection without substitution.
