**\$140 buy-in (\$113 prize pool + \$27 administrative fee)**

Players will start with 6,000 in tournament chips.

- Administrative fee includes any and all staffing/dealer fees, and rake.
- \$113 will go into the prize pool. \$17 is the registration fee. \$10 will go towards the staff token pool.
- Prizes: Approx. 1 in every 10 entries will win an entry into the \$1,125 WSOPc Event #8.
- Remaining money in the prize pool will be distributed to the next highest placing participant.
- This is a re-entry event. If a player is eliminated during registration period that player may re-enter same event.
- Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
- On Site Registration and unlimited Re-Entries will remain open until the start of level 9. No Refunds.
- Players may forfeit their stack in order to Re-Enter during the close of registration break only.
- Management reserves the right to alter, change, or cancel this tournament. Management will not be held responsible in the event of typographical errors or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters. Tournament Director's decisions are final and without recourse.
- Any unauthorized chips introduced into tournament play will be immediately removed upon detection without substitution.
