5. Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
6. Levels will last 10 minutes each. Seating may be limited for this event.
7. One (1) in every ten (10) players will win \$25,500 entry into **LHPO High Roller Event #20 on January 22nd, 2018.**
8. Residual cash will be paid to player who finishes next after all \$25,500 prizes have been awarded.
9. Management reserves the right to alter, change, or cancel this tournament. Management will not be held responsible in the event of typographical errors or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters.
10. Any unauthorized chips introduced into tournament play will be immediately removed upon detection without substitution. Any parties determined to be responsible for the introduction of said chips will be disqualified without refund.
