3. Players may forfeit their stack in order to Re-Enter.
4. Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
5. Levels will last 20 minutes each. Seating may be limited for this event.
6. A single ante will be paid from the big blind for the entire table. *The ante is paid before the Big Blind.*
7. One (1) in every ten (10) players will win a \$1,650 entry into the **2019 Lucky Hearts Poker Open Event #23 on January 21st, 2019.**
8. Residual cash will be paid to player who finishes after all \$1,650 seats have been awarded.
9. Management reserves the right to alter, change, or cancel this tournament. Management will not be held responsible in the event of typographical errors or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters. Tournament Director's decisions are final.
10. Any unauthorized chips introduced into tournament play will be immediately removed upon detection without substitution. Any parties determined to be responsible for the introduction of said chips will be disqualified without refund. It's each and every player's responsibility to bring to management's attention unusual chips, circumstances, or irregularities.
