- 6. One (1) in every ten (10) players will win a \$5,000 entry into Poker Showdown Event #26 on Tuesday, April 16th.
- 7. Residual cash will be paid to the player who finishes next after all \$5,000 seats have been awarded.
- 8. Management reserves the right to alter, change, or cancel this tournament.
