4. A single ante will be paid from the big blind for the entire table. The ante is paid before the Big Blind.
5. One (1) in every ten (10) players will win a \$1,100 entry into the **Saturday May 4th \$50K GTD Big Slick.**
6. Residual cash will be paid to player who finishes after all \$1,100 seats have been awarded.
7. Levels will last 20 minutes.
8. Management reserves the right to alter, change, or cancel this tournament. Management will not be held responsible in the event of typographical errors or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters. Tournament Director's decisions are final.
9. Any unauthorized chips introduced into tournament play will be immediately removed upon detection without substitution. Any parties determined to be responsible for the introduction of said chips will be disqualified without refund. It's each and every player's responsibility to bring to management's attention unusual chips, circumstances, or irregularities.
