4. Alternates and late sign-ups will enter the tournament with a full chip stack and no obligation from it.
5. Levels will last 15 minutes each.
6. One (1) in every five (5) players will win a \$300 seat into the **Step II High Roller Satellite on Sunday, November 17th, 2019.**
7. Residual cash will be paid to the player who finishes after all \$300 seats have been awarded.
8. Tournament Director's decisions are final.
9. This is a one-day tournament and plays until completion. Seating may be limited for this event.
10. Management reserves the right to alter, change, or cancel this tournament. Management will not be held responsible in the event of typographical errors or misinformation on the website or printed material pertaining to this event, and players will have no claim in these matters.
11. Any unauthorized chips introduced into tournament play will be immediately removed upon detection without substitution.
